Bridgehead Business Park, Boothferry Road, Hessele

PPH's Office Agency team has been working with developer, Wykeland, on the 50-acre Bridgehead business park from its initial conception, negotiating all of the lettings and sales for a diverse range of properties, from Grade A purpose-built space to business centres such as the ergo building that offer versatile and flexible office space.

The site has the capacity for 612,000 sqft and can accommodate 5,000 sqft to 100,000 sqft units. The high quality, unique location and future focused, green credentials in place at the site have attracted household names such as Porsche and Centrica. Many of these tenants have purpose designed offices, which have been tailored to their particular specifications and requirements.

The location of the site boasts excellent transportation links, making Bridgehead an ideal strategic choice of location for our tenants, including John Good Shipping, who chose a bespoke 6800 sqft complex on the business park to house their head office.
